

We the Irrelevant queried legislators via open records requests. They were asked to provide records of all citizen contacts received within a specific time frame, including letters, emails, and phone calls. Those contacts were tallied and published at [www.we-the-irrelevant.org](http://www.we-the-irrelevant.org). This spreadsheet lists the issues/bills queried, how many contacts were opposed, how many were in favor, and how the legislator voted.
